

THE PET BARRACKS AGREEMENT, RELEASE AND MEDICAL POWER OF ATTORNEY

Terms: Pets may only be dropped off or picked up during THE PET BARRACKS normal business hours. By signing this Agreement, you are agreeing to pay THE PET BARRACKS for all services rendered, including veterinary fees or other charges your pet may incur while at THE PET BARRACKS. The pet will not be returned to their owner until all charges are paid in full. THE PET BARRACKS operates a clean and safe environment for pets. However, as pet owners know, accidents happen. THE PET BARRACKS will use its best efforts to maintain its facilities in a safe and sanitary manner. By signing this Agreement, I represent that I am the legal owner of my pet or agent for owner, and that my dog has current vaccinations including but not limited to vaccinations against distemper, parvo, leptospirosis, Bordetella, and rabies. I understand and acknowledge that my pet will be kept in the company of other pets during its stay here at THE PET BARRACKS. I give THE PET BARRACKS permission to take pictures of my pet for use in its advertising and promotional materials, and any pictures so taken become the property of THE PET BARRACKS. I understand that THE PET BARRACKS may terminate my pet's stay at any time in its sole and absolute discretion, and that if my pet's stay is terminated I will promptly pick up my pet, or send an agent to do so. I understand that daycare packages are non refundable. I understand that Boarding fees, Daycare, and Grooming treatments are nonrefundable. I understand it is my responsibility to inform THE PET BARRACKS of any known allergies or medical issues my pet has. I understand THE PET BARRACKS will charge \$3.00/day for administering oral and topical medications. I understand THE PET BARRACKS may decline service at any time at its sole discretion. I agree that if I pay by check and the check bounces THE PET BARRACKS may charge the full amount due plus a returned check fee of \$25. I understand that if I am unable to pick up my pet on the designated check out day, I will call THE PET BARRACKS and extend the reservation. If I do not contact THE PET BARRACKS or pick up my pet within 3 days after the checkout day, THE PET BARRACKS will use its sole and absolute discretion to rehome my pet.

Assumption of Risk: I hereby give THE PET BARRACKS permission to care for my pet and to do any and all things required in the ordinary and normal course of providing such care. THE PET BARRACKS may use leashes, spray bottles, muzzles or other appropriate means of maintaining control over my pet. I understand that THE PET BARRACKS is not responsible or liable for any of the following: injuries (or death) to my pet caused by other pet (including being bitten); diseases or ailments which my pet may contract from other pets; including infections and viruses; falls; theft; collisions with vehicles; running away; natural disasters; fire; the unavailability of emergency medical care or any items necessary for the care of my pet due to circumstances beyond the control of THE PET BARRACKS; the negligence or deliberate acts of third parties; or injuries or death to my pet caused by themselves including but limited to ingesting foreign objects, chewing themselves, chewing foreign objects, or running away. I understand that THE PET BARRACKS is not responsible for any personal property left with THE PET BARRACKS, including but not limited to beds, blankets, clothing, food, bowls, collars, leashes, or toys.

Veterinary Care: If, in my absence, my pet should be injured, appears sick, or otherwise requires immediate veterinary attention as determined by THE PET BARRACKS in its sole and absolute discretion, I hereby authorize THE PET BARRACKS to consult with any veterinarian for treatment or guidance. I authorize THE PET BARRACKS to utilize the services of any veterinarian selected by THE PET BARRACKS. I understand that I am responsible for any charges, including transportation costs, incurred with respect to any such veterinary services. I name THE PET BARRACKS as my attorney-in-fact to act in my name to accomplish the foregoing.

Release of Liability and Indemnification: I hereby release THE PET BARRACKS, its shareholders, officers, directors, employees, contractors, agents, or any other person or entities involved with the services provided by THE PET BARRACKS from all actions, suits or claims for injury, loss or damage regardless of the cause (with the sole indiscretion of intentional wrongdoing of the Owner). I understand and acknowledge that animals can be extremely unpredictable and may cause damage to themselves, other pets, persons or property for which THE PET BARRACKS could be liable. I agree to indemnify and hold harmless THE PET BARRACKS and Owner for any and all losses, liabilities, demands, expenses, claims and suits, including and legal, veterinary or other fees THE PET BARRACKS or owner may incur as a result of any damage cause by my pet, and I agree to defend THE PET BARRACKS and Owner against such. It is the intention of the parties that the foregoing releases shall be effective as a bar to all actions, claims, losses, liabilities, damages or costs, of any kind or nature, known or unknown, foreseeable or unforeseeable, arising out of the performances of THE PET BARRACK'S services. The parties expressly agree that this release of liability and indemnification shall be given full force and effect in accordance with each and all of its terms and provisions

I understand that this Agreement is a contract between THE PET BARRACKS and me, and that it contains a power of attorney, release of liability and indemnity. If any portion of this Agreement is deemed unenforceable, all other portions shall be given full effect to the extent possible. In the event of a dispute between the parties, the prevailing party shall be entitled to recover all costs and expenses incurred therein, including attorney fees. This Agreement contains the complete understanding of the parties with respect to the subject matter herein and supersedes all prior representations and understandings, whether oral or written; and only a writing signed by both parties may modify this Agreement.
